• Congratulations to **Accessible Properties** who are to purchase more than 300 homes from Hamilton City Council. The 344 homes are currently tenanted by people in their retirement – this proposal means tenants will be able to remain in their homes.

Accessible Properties General Manager Andrew Wilson says, "We have a long history of supporting people who need good quality housing and we look forward to being able to extend that to more people in Hamilton. We are also committed to modernising and improving the newly acquired homes."

• Auckland Council, has endorsed a recommendation from Panuku Development Auckland to enter into partnership with an undisclosed community housing provider to manage and further develop its portfolio of 1,412 homes for older Aucklanders. The partnership will be formally announced when the MOU is finalized. Public consultation will be carried out in early 2016.

Are you a CHP or a CHO?

Confused by these terms? Here's our take on the distinction.

A community housing organisation (CHO) is any community-based housing service who shares the following characteristics:

- Not-for-profit organisation
- Representative of and engaged with the communities they work
 within
- Responsive to their tenants
- Have the goal of providing long-term, affordable and appropriate housing
- May have more than one service they provide in their community.
- May or may not receive Government funding.

Community housing providers (CHP's) on the other hand, is the term we use when referring to organisations regulated under the Community Housing Regulations Authority (CHRA).

Do you agree? CHA's style is to use the inclusive community housing organisation term for our members as widely as possible, and the narrower CHP term when it is relevant.

In the news

• New social housing places in Auckland have been announced. Expected to deliver 500 new houses under the IRRS scheme, Government have made provision for a \$10 million cash injection and leases for between 10 and 25 years. See more here.

• New Zealand is facing a growing population of homeless older people warns the Salvation Army in a new report. The organisation has released new research estimating that by 2030, 200,000 retirement-aged people won't own a house and will be unable to afford rent. Over the next decade, the numbers needing state help to cover their rent is expected to rise considerably: from 35,000 this year to 100,000 by 2025. See more here.

Proposed residential tenancy act ammendments

On 3 December the Government introduced to Parliament the Residential Tenancies Amendment Bill and also released for consultation the associated proposed regulations for insulation and smoke alarms. The insulation requirements will apply to Government contracted social housing providers from 1 July 2016 and to other tenancies from 1 July 2019.

All landlords will need to disclose in tenancy agreements from 1 July 2016, the extent of insulation in their rental property. Smoke alarms will also need to be installed in all residential rental homes by 1 July 2016. Regulations will make landlords responsible for ensuring operational smoke alarms are installed in their properties, and tenants responsible for changing batteries and reporting faulty alarms.

The regulations on insulation and smoke alarms will be consulted on in parallel with the Select Committee process. Details on the quantity of insulation and number of smoke alarms required will be determined in the regulations. The regulations will also set under what circumstance a property can be excluded. **Consultation is open from Thursday 3 December 2015 and closes 11pm on Thursday 10 February 2016.
