#### Scaling up for Our Place



As we've listened to your feedback on **Our Place** we've heard that we could reframe 'Homes for 50,000 more New Zealanders by 2020' into one where the sector's contribution toward the goal is better aligned with our rate of delivery.

Based on your comments, a revised goal of 'Homes for 50,000 more New Zealanders by 2030' is offered for your endorsement. This goal means scaling the sector up to deliver 1,000 homes per year, both social and affordable, for the next 15 years.

Together, we can achieve this. We are a sector with a plan - and it's up to us to deliver. The December 2016 release of the Ministry of Social Development purchasing strategy provides funding for 3,800 homes through to June 2020. That's funding at the scale that matches our goal for the social housing part of the continuum. We now need to get the settings right to action the affordable part of the goal.

As a sector, we're currently delivering around 350 homes per year. So it's up to us to increase the delivery by three-fold. We have heard from you about the many ways you are doing that. CHA is here to assist your efforts and promote sharing the many models gaining traction.

### Timeframe likely to be extended beyond 31 March for Income Related Rent Subsidy RFP

CHA has been advised by MSD today that:

"MSD is currently considering extending both the timeframe and coverage of the current RFP for **New Social Housing Supply Outside of Auckland**. We are also considering further ways in which we can support providers to help deliver the supply of social housing places sought through our Purchasing Strategy and will soon be engaging with the wider sector on how this can be achieved."

This is welcome news on the Requests for Proposals for new social housing supply in Whangarei, Hamilton, Wellington, Lower Hutt and Christchurch, **currently due to MSD by 31 March**.

The December release of the MSD Purchasing Strategy which seeks to purchase 3800 additional IRRS places across New Zealand is a much wider, four-year funding pool. There is funding available now for new supply in most regions around the country. If you have any new supply opportunities in your local area, check the regional summaries contained in the strategy and talk to MSD now to clarify what you will need to make it stack up.

## Tamaki expressions of interest for tenancy management

The Tamaki Housing Association (THA) is the wholly owned tenancy management services business of Tamaki Redevelopment Company Ltd (TRC). The recently established Social Services Procurement Capability Team within the Ministry of Business Innovation and Employment (MBIE) want social services to be competently procured and managed meaning:

- it's easier for you to do business with government
- information is clear and easy to understand
- you experience effective working relationships with government, and
- there's an opportunity for innovation.

### Research

**Disability and housing conditions: 2013** compares housing characteristics of disabled and non-disabled people living in private

dwellings using data from the 2013 New Zealand Disability Survey (NZDS).

Findings from the 2013 Disability Survey showed people in rented homes were more likely than people in owner-occupied to report difficulty keeping their house warm. 25 percent of disabled people reported having difficulty keeping their home warm, compared with 18 percent of non-disabled people.

More than 30 percent of disabled people who rent experience damp. The rate for non-disabled renters was just less than 25 percent. The 2013 Disability Survey also found one in six people with an impairment (16 percent) needed some modification to their homes – most commonly changes to their bathroom. One in four (25 percent) disabled people with a physical impairment needed bathroom modifications and about one in six (17 percent) said they needed changes to their home entranceway. <u>See Disability and housing</u> conditions: 2013 for more details.
