The CHA Council met with Minister Bennett during its 9 June 2015 meeting in Auckland. We were advised that a further proposal has been put to Cabinet, and we are all anxiously awaiting the result. We will keep you posted and provide analysis on any solution.

# MSD responses to our questions on Flexible Purchasing Act anticipated soon

# MSD releases RFP for the 300 additional social housing places in Auckland

Providers who were selected through the December 2015 Expression of Interest process have now been invited to submit full proposalshere

Remember that the social housing register shows MSD needs to purchase at least 1810 total places in Auckland- so we would expect the results of this RFP to then progress into an open process for the remaining 1510 places.

# Auckland Council Seeks Community Housing Partner

On 11 June 2015, the Auckland Development Committee approved a proposal to seek a community housing partner for its Housing for Older Persons. Auckland Council currently owns 1,412 Housing for Older Persons (HfOP) rental units. The link to the report is here. Read the Council press release here.

### **Nelson Housing Accord**

The Nelson City Council and Government signed a Housing Accord targeting consents for 720 new dwellings over the next three years. According to the press release, which can be found here, "It is the eighth Accord we have agreed with local councils to date, after Auckland, Christchurch, Wellington, Tauranga, Western Bay of Plenty, Queenstown Lakes and Tasman."

It is interesting that while the Government is pressing ahead with an Accord in Nelson, the purchasing intentions released by MSD indicate a need for only 10 one bedroom units. Surely if there is a need for 720 new affordable homes, there must be additional demand for social units.

# **Productivity Commission: Using Land** for Housing Draft Report

The Government has asked the Productivity
Commission to review the local planning and
development systems of New Zealand's fastestgrowing urban areas and identify leading practices that
are effective in making land and development capacity
available to meet housing demand. The Productivity
Commission has now released its draft findings and
recommendations. Stephen Olson with
Newsroomplus attended the release news conference
and has a blog post which provides a good overview
of the many complex issues being addressed.

The Commission is seeking submissions on the Draft Report, particularly on the draft findings and recommendations, by 4 August 2015. The final report will be delivered to Government by 30 September 2015.

## Productivity Commission: More Effective Social Services

The Productivity Commission has also been asked to look at ways to improve how government agencies commission and purchase social services. This will include how agencies identify the needs of people who use the services, how they choose organisations to provide the services, and how the contracts between agencies and organisations work. The draft report was released on 28 April 2015 and the submission period closes on 24 June 2015. Review the report and details of how to make a submission here.
