Dwell Housing and Ark Trust deliver innovative solution to preserve affordable housing

An initiative that has united two Wellington-based trusts in a common goal has been welcomed by those keen to secure housing for the city's more vulnerable residents.

Ownership of five homes built in the early 1980s by the Wadestown Ark Trust was transferred in late June to Dwell Housing Trust. The Ark Trust was originally established by the Wadestown Presbyterian Church, Wellington, in partnership with its neighbouring Anglican congregation, to provide affordable accommodation in the area.

The ownership transfer was required as the small Trust Board struggled to find the human resources within the churches to take on the responsibility for the homes, while changes to retirement village law and compliance requirements also impacted on how the accommodation was managed. Working with Dwell was seen as a solution that would preserve the Ark Trust's intent and offer security of tenure for residents. Read more here.

BRANZ developing guide for medium density development



Working alongside Beacon Pathway, <u>BRANZ have been developing an assessment tool to guide good practice</u> for medium density development in New Zealand.

The purpose of this project is to identify and quantify the benefits of medium density housing as a housing option. This could include the lower cost of medium density housing compared with standalone homes, as well as the fact that it is often closer to amenities and to inner-city workplaces. The project will run until 2018, and will have

several phases. It will start with work to identify the existing attitudes and perceptions of medium density housing. The next phase will assess insights around the pros and cons of medium density housing as a choice.

After reviewing nine of the most relevant existing approaches to the guidance and assessment of medium density and built form, they've identified key concepts which a New Zealand and medium density-specific framework would need. You can read more about this here.


CHA submission on MBIE fire safety draft design guide

We have prepared our submission on the MBIE fire safety draft design guide which is of great interest to our members providing residential community housing.

Community Housing Aotearoa agree the need to develop a reasonable alternate solution to the requirements of the Acceptable Solution C/AS3 which came into effect in July 2014. We are one of the stakeholders who has worked with MBIE over the past three years to develop the Draft Design Guide. During that time we have engaged with our members to understand their concerns and keep them informed regarding progress toward an alternate solution.

In addition to our members, CHA has worked closely with the New Zealand Disability Support Network, the Disabled Persons Assembly and MBIE to develop our response which can be found here.
