Housing more refugees

The Government has announced that New Zealand will welcome an additional 750 Syrian refugees over the next two and a half years in response to the ongoing conflict in Syria. A number of Government and Non-Government Agencies will be involved in the settlement of these emergency refugees. It is highly possible that community and social housing providers will be called upon to provide housing for our new residents.

Congratulations to the Tauranga Community Housing Trust who will take ownership of 79 pensioner housing units on October 1 after purchasing them from Whakatane District Council. TCHT Manager Chris Johnstone says the Trust is excited to have the opportunity to extend its social housing services into the Eastern Bay of Plenty. Sam founded Pathways to Housing in 1992, based on the belief that housing is a basic human right. There he developed the consumer-

driven Housing First model, which provides immediate access to permanent supportive housing for people who are homeless. 
