### Auckland Unitary Plan takes a step backwards

Disgruntled ratepayers jeered and booed at a special Auckland Council meeting on Unitary Plan residential zoning last week. The plan proposes to intensify housing in areas of the city that were previously off the radar but there is opposition from some residents in those suburbs.

CHA Senior Project Manager, Hope Simonsen, was at the meeting supporting Peter Jeffries from CORT. Hope says, "Peter demonstrated very clearly the significant cost savings made by building three storeys and in these residential hub areas. He also made it very clear that the need for one and two bedroom units is very high for social housing purposes – and will continue to be going forward.

"The Council's decision not to go ahead with the rezoning is a step backwards for the supply of affordable housing for Auckland. Supply of housing through intensification is a critical component for generating affordable housing for Auckland city – who's housing is now 5th least affordable in the world. A year ago it was the 9th.

"Affordability is not just about home ownership – it's also about renting. There is a significant and growing population that will be renting for a very long time and increasing the volume of units around service centre hubs helps improve affordability. It reduces transport

costs and increases proximity to employment opportunities and schools," commented Hope.

Hope believes that the proposed Auckland Unitary Plan does not go far enough and, without significant changes, means Auckland's supply based on projected demand will be short-changed by around 200,000 units. "The plan should be about the future, not designed to submit to the status quo of single, stand-alone large homes on large sites. Increasing density doesn't have to mean creating ghettos — good design and controls are appropriate mechanisms for ensuring Auckland gets quality housing."

Also speaking at the meeting were the Auckland Youth Advisory Council and Generation Zero. Sudhvir Singh, from youth lobby group, Generation Zero, supported the new zoning proposed by Auckland Council. He said young people would rather live in small, well-designed apartments in central suburbs rather than in houses on the outskirts. He was heckled as he told councillors they need to consider the views of younger people. The Youth Advisory Council also endorsed the plan changes. Alex Johnston of the Youth Advisory Council said the voices of the young had been drowned out by an older generation already on the property ladder.

# An in-depth look at the Christchurch housing situation

## Financial Markets Conduct (FMC) Act resource for charities

Under the old rules, anyone wanting to raise money from investors by offering debt securities was required to have a trustee, registered prospectus and investment statement. Registered charities were exempt from these requirements. But from 30 November 2016 the exemption will end and the new rules will apply to everybody. This means that all community and voluntary organisations, including registered charities, wanting to raise money from Investors will need to become familiar with the new rules.

Here is a guide to help you understand your options for raising funds under the FMC Act.

#### In the news

- Christchurch City Council has completed the first key step in setting up a charitable trust that is proposed to take over management of its social housing service in the second half of this year.
- Social Housing Reform (Transactions Mandate) Bill passed into law. We await the announcement on 16 March when the shortlist is announced for the preferred providers to enter into the next step of the process –request for proposals.
- Details of Auckland emergency housing funding were announced. Paula Bennett announced that CHA member Emerge Aotearoa will provide 30 emergency housing places for individuals or families. Further announcements on a more long-term funding model for the emergency housing sector nationwide will be made in the next few months.
