## 1. Outline of involvement in community housing sector

Growing up in Council housing in Northern Ireland, I experienced first-hand the importance of secure, affordable housing. Since then I have worked in housing in Australia and NZ. I have completed housing studies for local and state government as well as developers for green field and brown field sites.

I have conducted empirical research for government and non-government agencies in homelessness, social housing renewal and regeneration including a PhD study that investigated "who benefits from social housing regeneration projects?". This study was funded by the Australian Housing Urban Research Institute and NSW Department of Housing. I have a Master's degree in Urban and Regional Planning which investigated the use of developer contributions in funding social infrastructure in greenfield developments.

In 2002 I developed a Social Sustainability policy for Landcom in NSW establishing thresholds for inclusionary zoning and compulsory affordable housing targets in new residential developments in NSW. I set up Compass Housing NZ in 2005.
