#### Budget 2019 - what are your priorities?

Planning for Budget 2019 - the Wellbeing Budget - is underway across ministries. Community Housing Aotearoa provided our ideas for funding priorities to the Ministry of Housing & Urban Development. We would like to see resources to activate supply across the continuum and build the capacity of Māori and Pacific providers. Our requests are summarised as:

- Resources to prevent and respond to homelessness: new funding for prevention delivered by Community sector, increased funding for transitional and Housing First.
- **Social Homes**: an additional 1,000 IRR places per year for the next five years to see 2,600 new homes built each year (up from current 1,600).
- Affordable Rental Homes: to provide pathways out of emergency/transitional programmes and social rentals, an Affordable Rental Housing Capital Fund of \$100 million per year for 10 years.
- Assisted Ownership Homes: to provide pathways from renting to ownership, a Progressive Ownership Capital Fund should be established and delivered by non-profit registered Community Housing Providers. Indicative funding at \$75million/year.

## Dwell celebrates five years in business and a new build

In 2013 Wellington Housing Trust and Mahora House Inc joined together to create Dwell Housing Trust. Recently Dwell took the opportunity to mark the fifth anniversary of this very successful merger with a celebration at their latest building site. With capital funding from government, Dwell is currently building 14 well-designed, healthy, quality homes for people in need and who are on the social housing register, on the site of the old Mahora House.

Dwell Chief Executive Alison Cadman spoke about the importance of the past and how Mahora House was set up in the late 1980s by people who had a heart for those in need of housing. "Almost 40 years later the need for us to come together to support people into affordable homes is stronger than ever."

While acknowledging the importance of all the work done by many in the past, thanking all those people and businesses who support their work today, Dwell also looked to the future and emphasised the need for the right settings to be in place, so community housing can continue to grow to scale.

## Palmerston North social enterprise builds \$2.5 million worth of Homes for People in its first year

A Palmerston North programme that created 11 affordable houses in its first year has almost twice as many homes on the drawing board for next year.

Homes for People has marked its first anniversary, celebrating providing housing collectively worth \$2.5 million for people on lower incomes to buy. The social enterprise has 21 homes planned for next year.

It has already helped dozens of people – like Alesha Thomson, who will move into the Wakefield St development when it's completed in six weeks.

#### Initial findings from Ira Mata, Ira Tangata: Auckland's Homeless Count announced

Initial findings from Auckland's first region-wide count of people living without shelter and in temporary accommodation were announced on 9 October.

The findings show 800 people are estimated to be living without shelter and 2,874 people were in temporary accommodation in Auckland on 17 September. A full report will be available towards the end of the year.

#### ACHPN views on density and tenure mix

The Auckland Community Housing Provider Network recently weighed in regarding the need for mixed-income, mixed-tenure

communities at a 28 September meeting of Auckland Council.Read ACHPN's letter here.

The letter addresses the role of local Government across New Zealand to influence the quality and mix of housing types and tenures for regeneration projects as they occur. This is highlighted in the videos below of the public meeting at Auckland Council on 28 September wherein the Auckland Mayor Phil Goff, and other City Councillors, discuss the matter with John Tamihere (the property developer).

Network members confirmed their support for initiatives to increase the supply of new housing, including housing intensification. However, they express concerns about plans to develop high concentrations of limited tenure housing in many communities in Auckland. They advocate that new housing development should roughly have a housing tenure mix that provides public rental housing (between 20% to 30%), affordable housing options (30% to 40%) and competitively priced market housing (20% to 40%). The final split of tenures is determined by the community's household cohort needs.

Paul Gilberd from the Housing Foundation says:

"If we don't care about this, as Community Housing providers, we are in the wrong business. Who do we think is going to be cleaning up the mess for the next generation?"

#### KiwiBuild – Invitation to Participate – Buying off the Plans

We received this email from the KiwiBuild 'Buying off the Plans' team.

The KiwiBuild Unit has reopened the Invitation to Participate (ITP) for the Buying Off The Plans initiative and is seeking new proposals. There is no deadline for this ITP. Interested developers can choose to register their interest at any time.

The ITP has been advertised on the Government Electronic Tenders Service website where you will find the registration form and the supporting documentation you require, along with the instructions on how to respond.

The application and evaluation process has been streamlined from our initial Buying Off The Plans initiative and we now require that all proposals are submitted electronically.

#### **Healthy Homes Guarantee Act**

The Ministry of Housing & Urban Development is also consulting on proposed regulations for the Healthy Homes Guarantee Act (No 2), which passed into law in December 2017, amending the Residential Tenancies Act 1986.

The Healthy Homes Guarantee Act enables the government to create regulations that set minimum standards for rental homes — the Healthy Homes Standards.
