### Community housing ready to go

Radio New Zealand reports that the community housing sector is ready and waiting to construct nearly 3000 homes but desperately needs public cash to get building.

Housing providers have submitted their projects to the Government in a bid to get investment through the 'shovel ready' infrastructure project.

## COVID-19 response reveals hidden homelessness

Radio New Zealand's Nine to Noon programme reports that the true extent of New Zealanders in insecure housing was exposed during the COVID-19 response, leading to calls for a national homelessness strategy and to make housing a legal right.

Lynn Freeman talked to Clare Aspinall at the University of Otago in Wellington, who is currently researching the benefits and challenges of using the Housing First approach in a New Zealand context, Massey University 's societal psychologist Darrin Hodgetts whose research focuses on urban poverty and homelessness, and Rolinda Karapu from the Ngā Pae o te Māramatanga research centre who is a senior advocate based at Waikato Women's Refuge.

## **Governance vacancies - National Science Challenges**

Challenge Governance Group member and co-chair (two vacancies)

The National Science Challenges are designed to find solutions to some of the large, complex issues that matter most to New Zealanders.

The Building better homes, towns and cities: ko ngā wā kāinga hei whakamāhorahora Challenge aims to address some of the significant issues facing our country. Its activities focus on areas such as housing supply, the quality of our housing, and the vulnerabilities and underperformance of some of our urban environments.

The role of the Challenge Governance Group is to provide oversight and direction to this important National Science Challenge. Background information about the Challenge and its work can be found here.

Applicants with experience in the following areas would be particularly welcome:

- affordable or social housing
- local or regional government
- science sector experience and leadership
- kaupapa Māori.

The National Science Challenge welcomes applicants from diverse backgrounds.

# Deadline extended for healthy homes standards compliance statement

The deadline for landlords providing a compliance statement for the healthy homes standards has been extended from 1 July 2020 to 1 December 2020.

### **Understanding the Building Code**

The Building Performance team within the Ministry of Business, Innovation and Employment has provided a number of online learning modules to help understand the Building Code, performance requirements, and compliance.

Building Performance says this follows the Government's announcement that it is making it easier for people to do more low-risk building work without needing a building consent, as long as the work meets the requirements of the Building Code. These changes are expected to come into effect at the end of August.

The introduction to the Building Code modules are broken into sections focusing on The Building Code, Building Performance Requirements and Building Consent Compliance. They are between one and three minutes long, easy to use and come complete with an assessment at the end (they are short videos to watch, so you may need headphones).

- 1. The Building Act
- 2. Roles and Responsibilities
- 3. The Building Code

### **Building Performance Requirements**

- 4. Code Clauses
- 5. The Structure of the Building Code
- 6. Performance Measurement

- 9. Information and Guidance
