The Government's announcement included \$400 million for a progressive home ownership scheme that could include rent to buy and shared ownership plans, among other things:

We responded positively to the Government's announcement, and acknowledged initiatives such as KiwiBuy as an example of an innovative approach offering a good pathway into home ownership for New Zealand families:

# From sleeping rough to home ownership in Kaitaia

A Kaitaia-based housing and social services provider is offering hope for people who have been homeless or living in sub-standard accommodation to aim for home ownership of recycled state houses.

Radio New Zealand's Nine to Noon programme talked to He Korowai Trust Chief Executive Ricky Houghton about the Whare Ora scheme and also Hayleigh Te Hira, who was due to move into one of the houses shortly.

#### Finally, their very own home

After more than 30 years living in state housing, a Glen Innes whanau are unpacking their boxes in their very own home, bought through a shared home ownership arrangement with Tāmaki Regeneration Company (TRC).

Housing Foundation is the delivery partner working alongside whanau to progress from renting to owning. This is the type of programme the sector will be able to scale up with the progressive home ownership announcements from government. The Minarapa whanau are the first to take advantage of TRC's shared home ownership programme, which begins this month with the first six whanau getting ready to move into brand new homes.

Shelley Katae from TRC says it's not just about being able to put your own photos on the walls. "It's about stability for your whanau, keeping your kids at the same school and it's an asset for your entire whanau for generations to come."

### Kāinga Ora - Homes and Communities Bill

The Kāinga Ora - Homes and Communities Bill amendments have been released. Only minor amendments were made to the bill. Notably the renaming of the Housing Restructuring and Tenancy Matters Act 1992 was amended to the Public and Community Housing Management Act 1992, better reflecting the role of the communicy sector in addition to government. # The going got tough in Lifemark's Age Lab

The housing development team at CHA member Accessible Properties has had a small taste of what it's like to cope with physical limitations.

Three members of the team recently spent time in an Age Lab at LifeMark in Auckland. The housing design organisation's Age Labs help people to understand the challenges people face when they age or have mobility issues.

Team members tried on simulation glasses that mimic age-related visual impairments, an age-simulation weight vest that made it difficult to move around, a wheelchair, and equipment that restricted the wearer to using just one side of their body.

## **Recognition for the Healthy Homes Initiative**

The first annual Spirit of Service award has been won by the Ministry of Health and five agencies who teamed up on the Healthy Homes Initiative.

This initiative was a collaboration led by the Ministry of Health with Housing New Zealand, Ministry of Social Development, Ministry of Business, Innovation and Employment, Energy Efficiency and Conservation Authority, and Auckland Council.

The initiative aims to help reduce hospitalisations by helping to create warm, dry, healthy homes for low income families. The award celebrates outstanding public services delivering great outcomes for New Zealand.

## New information requirements - Family Violence Act and Oranga Tamarki Act

In our 6 August newsletter we advised that we have been working with the Community Housing Regulatory Authority (CHRA) to clarify the impact of legislative changes for our members, and CHRA has now written to providers with more information.

It advises that all registered community housing providers are expected to have privacy and personal information policies in order to comply with Performance Standard 4(C) "The provider has documented systems and processes to ensure that confidentiality of all tenancy information is maintained".

Ordinarily, the Privacy Act 1993 would apply to decisions made by registered CHPs about sharing personal information. However, CHRA says that since 1 July 2019, the Family Violence Act 2018 and the Oranga Tamariki Act 1989 have imposed requirements on registered CHPs that over-ride the Privacy Act in some circumstances.

https://www.orangatamariki.govt.nz/assets/Uploads/Informationsharing/information-sharing-Guidance-OT-Act-1989.pdf. CHRA recommends reading these guides carefully to ensure you are aware of your obligations under both Acts.

It also says all registered CHPs should provide their updated privacy and personal information policy to CHRA as part of 2019/20 annual monitoring, along with all other documents required as part of the annual monitoring process.
