Schedule for visit by UN Special Rapporteur

We can now provide further detail on the visit to New Zealand from 10–19 February by Leilani Farha, the UN Special Rapporteur on the right to adequate housing.

CHA Chief Executive Scott Figenshow says Ms Farha will be seeking to engage on two main areas of her work. The first is the extent to which houses in New Zealand are being used simply as a financial product rather than as great homes fostering wellbeing in communities. The second is to do with how a rights-based national housing strategy has worked in other countries and what lessons New Zealand might learn in order to ensure all New Zealanders are well-housed.

We are working with a range of service and housing providers to offer Ms Farha the opportunity to hear directly from residents and persons facing homelessness during the afternoon of Tuesday 11 February in Wellington, on the afternoon of Friday 14 February in Auckland, on

Also included in the current itinerary are a small number of RSVP events including a film screening in Wellington on 11 February, and an in-depth seminar on Housing Finance and Wellbeing in Auckland on 13 February.

Wellington: 10 -12 February

From 10 – 12 February Ms Farha will be in Wellington. Morning sessions involve engagement with Government. On Monday afternoon Ms Farha's key engagements include a series of meetings with various Commissioners and independent Crown entities.

Tuesday 11 February

Tuesday afternoon includes a series of site visits around Wellington with a focus on meeting families and individuals facing housing stress and risks to their rights to housing.

Public event: Screening of award winning documentary: The Push (Sweden, 2019, 92 minutes), featuring the work of the Special Rapporteur on the right to adequate housing around the globe on the issue of financialisation of housing (Director: Fredrik Gertten) 7pm, 11 February – Victoria University Wellington Lecture Hall (see separate note about how to RSVP for this event)

Ms Farha will introduce the film, with hosted Q and A. The event is free. Please contact [Ngahuia Wright](#) to ensure a seat.

Wednesday 12 February

Wednesday afternoon includes a series of meetings on tenancy rights issues, and human rights in New Zealand broadly. This programme will also include a briefing on current housing related research.

Auckland: 13 and 14 February

Thursday 13 February includes a marae visit and a Housing Finance and Wellbeing seminar as follows.

Thursday 13 February – 3pm – University of Auckland Lecture Hall (room tbc)

Seminar: Housing Finance and Wellbeing
The seminar will surface the connection between housing finance and wellbeing, in the context of growing recognition of the risks in the use of housing as a financial tool rather than as a home. It will help focus on the choices we have financing our housing stock to ensure wellbeing. The event is free.

In addition, meetings with the Mayors of Wellington, Auckland, and Christchurch are being sought.

Human Rights Commissioner: UN visit provides opportunity for scrutiny

Human Rights Commissioner Paul Hunt says we need to embrace upcoming the upcoming UN visit as an opportunity to assess how well we're doing.

Writing in The Spinoff, he says the UN visitors will acknowledge successes, make constructive suggestions and speak up when they see human rights failings.

Draft Urban Development Bill misses the mark

Thirty years of a lack of investment in genuinely affordable housing has given us homelessness and housing stress at an unprecedented scale.

The Government has a real opportunity to turn this around with its Urban Development Bill, currently open for submissions (due 14 February).

The bill follows on from the Kāinga Ora–Homes and Communities bill, which disestablished Housing New Zealand and set up a Crown entity in the same name.

It grants sweeping powers to Kāinga Ora, including compulsory land acquisition, streamlined consenting processes, setting and collecting development contributions and rates, and the ability to reconfigure infrastructure.

We want to support the Bill but have concerns that it has failed to pick up on the comments provided by CHA and sector partners on the legislation which established Kāinga Ora.

The current Bill does not require the development of any housing when these powers are used. While housing is enabled, nothing in the Bill requires any housing developed to be affordable or social housing. Further, the Bill does not provide a robust, statutory mechanism to ensure that any affordable homes developed will be retained so that mixed housing and communities are maintained over time. The Government could build a casino on the waterfront and not include any housing, let alone affordable housing.

We think this is a fatal flaw, one that must be remedied as the Bill proceeds through Select Committee. Our submission will indicate conditional support, subject to affordable and social housing being required in any development using the powers.

Failing to include a requirement to deliver genuinely affordable homes in the Urban Development Bill poses a risk for New Zealand's ability to recover from the housing crisis we are in.

As the draft legislation currently stands, the Government risks missing the point.

Further improvements we see needed in the Bill include:

- define affordable housing
- include registered community housing providers as both a key stakeholder and delivery agent
- add a third option for project selection – when put forward by local government
- create a SDP-lite process for these community-led projects
- expand the Betterment provisions to enable value uplift for affordable housing (by enabling tools like inclusionary zoning), in a community-led project.

CHA, Te Matapihi, and the CEO & Housing Leaders Forum wrote to Minister Woods in October last year to emphasise the need for the right mix of community and other expertise on the Kāinga Ora Board. We called for diversity, a commitment to whānau well-being, access to lived experience of housing need, business acumen, experience of community collaboration and partnerships, and kaupapa Māori service delivery.

We applaud Government for the appointments made and are confident that this new Board has the depth and range of expertise necessary for Kāinga Ora's success in working towards all New Zealanders well housed. We look forward to greater opportunities for partnership with community housing providers.

Update on workforce development framework

In October 2019, a group of community housing providers leaders met to discuss a workforce development framework for the sector. This workgroup was formed by the CEO & Housing Leaders Forum and is supported by CHA.

Representatives of the following organisations generously gave of their time:

- Community Housing Aotearoa
- Te Matapihi
- Emerge Aotearoa
- CORT
- Haumara
- Salvation Army
- Accessible Properties
- Otautahi Community Housing Trust

The discussion was wide-ranging, covering the perceived gaps in training available in New Zealand, the consideration of our Māori housing service providers and workforce, and ensuring that Te Ao Māori principles flow through all stages of training through to pilots currently underway and how to ensure best practice after training. This led to a discussion on whether the sector was large enough to support an accreditation and competency body.

To get us started we have agreed that there is merit in evaluating the learning outcomes of two pilots currently underway with the Australasian Housing Institute/CareerForce and Otautahi Community Housing Trust. The Workforce Group enthusiastically endorsed the suggestion that the sector develops Community Housing and Māori Housing 101 modules to sit alongside these existing pilots.

The Workforce Group pooled their knowledge and previous experience in housing, mental health, older person's health, and drug and alcohol sectors to develop a four-tier approach to the community housing provider workforce development and professionalism and validation of qualifications.

CHA is now working on a paper with the group that will be presented to the next CEO & Housing Leaders Forum and, if endorsed, there will be more detail available in a future CHA newsletter. This project is aimed to roll out over two to three years, with the first sector leadership days to occur around September or October 2020.

Sydney conference on housing as the foundation for mental health

The Australian Housing and Urban Research Institute (AHURI), in partnership with Mind Australia, is holding a one-day conference in Sydney on Wednesday 19 February on 'Housing: the foundation for mental health'.

Stable housing is critical for recovery from mental ill health and for being able to access appropriate support services. However, housing and mental health systems are not well integrated and, when they do connect, are crisis-driven. This means that many fall through the cracks and experience a downward spiral rather than being set on a path to recovery.

This conference will draw on new national data to examine the links between the mental health and housing trajectories of individuals.

The Australasian Housing Institute - Workshops 2020



The Australasian Housing Institute will be running workshops in Auckland and Hamilton in March on the subject of working with complex and demanding clients.

AHI says the workshops will help housing staff in direct contact with clients to develop their strategies and communication skills to work more effectively in difficult situations.

By the end of the workshop, participants should be able to assess complex situations, defuse and de-escalate situations, use assertiveness skills, self-manage, and learn from local knowledge of appropriate agencies for additional expertise and referral.

The Housing First Partners conference will be held in Seattle from 17-19 March 2020.

The first biennial conference was held in 2012 to further the conversation among practitioners about Housing First as a proven model for ending homelessness for those with chronic health conditions and long stints of experiencing street homelessness.

Since then, Housing First has been implemented across many elements of the crisis response and homeless systems and is being successfully applied in diverse interventions and as an overall community approach to addressing homelessness.
