National Māori Housing Conference 'Providing shelter and a foundation for whānau'

Last week, Ngati Kahungunu hosted the National Māori Housing Conference in Hastings. Themed 'Providing Shelter and a Foundation for Whānau' the three-day conference welcomed hundreds of attendees who heard from sector experts including community and iwi providers, about their experiences, successes, and involvement with papakainga developments. As part of the learning and kaupapa, attendees also visited local papakainga and saw first-hand the outcomes of developments created around whare, whenua and whānau.

Ministerial attendance included Associate Minister Māori Housing - Hon. Peeni Henare, Minister Māori Development - Hon Willie Jackson, Associate Minister Housing (Homelessness) - Hon. Marama Davidson and Minister of Housing - Hon. Dr Megan Woods. Supported by their agencies, the Ministers talked about their plans and commitment to iwi and reitereated their desire to partner with Māori and unlock Māori land for papakainga developments. The conference achieved good media coverage with Rau Hoskins appearing on TVOne news on Thursday evening. He recommended the Maori Housing Act be revised and be accompanied by an increase in funding of \$300m. Both



We have fitted your rooms out with all brand new furniture because you deserve to have a beautiful whare, we love you all, you are our whanau and our greatest desire is for you all to live well and be the happiest that you can be.

When you are all moved in, I have an image in my head of you all interacting with each other, having a coffee together in the centre courtyard, sharing stories, visiting each other and supporting each other. We hope that you enjoy calling this place your home. Big loves."

Alert Levels Reimposed

Prime Minister Jacinda Ardern announced a change in Alert Levels during a live announcement on Saturday, 27 February. Beginning at 11:59pm that night the greater Auckland region entered Alert Level 3 and the rest of New Zealand Alert Level 2.

Community Housing Aotearoa developed resources to assist providers to safely provide housing services during the initial lockdown periods in 2020. This information is still relevant and is available on our website. The guidance documents contain information, contacts, resources and advice to help you in your day-to-day service delivery and decision-making under the Government's Level 3 & 2 response to the COVID-19 pandemic. We urge all providers to review the resources to ensure your residents, staff and visitors have information available to maintain their health and safety.

Public Housing Plan 2021-2024 Released

Housing Minister Hon Dr. Megan Woods released the <u>Public Housing Plan 2021-2024</u> on 22 January. This document sets out the Government's public housing supply intentions for the next four years. It provides information about the location and number of additional public housing places that will be delivered by June 2024. The document supersedes the 2018 Public Housing Plan.

HUD will take both a kaupapa Māori (Te Maihi o te Whare Māori) and place-based approach to refine our understanding of local and community need, continue to identify priority focus areas for public housing supply, and deliver solutions that meet the immediate and long-term needs of vulnerable individuals, whānau and communities.

We anticipate further information from the Ministry of Housing and Urban Development regarding rent settings and the overall funding approach to be released in the coming weeks. We anticipate holding online meetings with MHUD to provide clear guidance to providers looking to deliver new supply. More details will be in future newsletters.

Upcoming Webinar 'Self-determined housing options for youth leaving care' by Brook Turner



Mark your calendar for this educational event presented by Manaaki Rangatahi Ki Tāmaki Makaurau and Community Housing Aotearoa (CHA).

Thursday 18 March 2021, 5:00pm – 6:30pm

Brook Turner is the Head of Service Development and Partnerships at Visionwest Community Trust. Brook has 20 years of social services experience and has learned a range of community development approaches including social enterprise. For his work in the social sector he has been awarded a Kiwibank New Zealander of the year local hero award, a Rotary International Paul Harris Fellow and a Royal Society of the Arts Fellowship from the United Kingdom. Brook is also a graduate and Alumni member of Leadership New Zealand. Brook believes the vital ingredients for social change are innovation, entrepreneurship, and a pursuit of greater equality across all ethnicities, genders and ages.

Brook is currently completing his Master's research is on 'Self-determined housing options for youth leaving care'. We know that young people leaving the care system fare worse than most in relationship to housing, often feeding our homelessness numbers from failed transitions out of care. Yet we rarely ask care leavers what they want in terms of housing. Brook's research looks at what we are doing here in NZ and internationally to address this as well as painting a comprehensive picture of the need and desperation many youth face without adequate housing. Join us in this webinar to hear Brooks insights and learnings through his Master's research.

Bianca Johanson is the Youth Strategy & Development Co-ordinator at Lifewise and she coordinates Manaaki Rangatahi Ki Tāmaki Makaurau: Youth

Homelessness Collective. Manaaki Rangatahi was formed in 2018 to address and work together as a sector to prevent and end youth homelessness in Tamaki Makaurau and Aotearoa. Their vision is a Tāmaki Makaurau where every child and young person has a warm, safe and secure place to call home.
