Hon Dr. Megan Woods, Minister for Housing formally announced the first phase of the Progressive Home Ownership programme on Friday 24 July. The first two of what are expected to be several providers selected, the Queenstown Lakes Community Housing Trust and Housing Foundation were on hand to celebrate the kickoff of the \$400 milllion programme. Both Minister Woods and MP Davidson were enthusiastic in their support for the programme and working with community housing providers on the delivery. Further announcements are eargerly anticipated for the organisations selected to deliver in the iwi/Māori pathway.

CHRA releases new Guidance Note

The Community Housing Regulatory Authority

Released a Guidance Note on 'Responsibilities under the Official Information Act' on Tuesday 21 July. This guidance outlines responsibilities of the Community Housing Regulatory Authority (the Authority) and community housing providers (CHPs) under the Official Information Act 1982 (the OIA).

The OIA requires that all information shall be made available on request unless there is good reason for withholding it. This guidance discusses the practical implications of that principle for you as a CHP and for the information that you provide to the Authority.

All registered CHPs and those organisations considering registration should read the guidance and understand the potential for the release of information they provide to CHRA.

Public Housing Rent Setting review 2020

The **Public Housing Rent Setting review 2020** was commissioned by **HUD** to better understand **Public Housing rent settings**, which were identified as an important area for further work in the wider Public Housing Funding Review (released in March 2020).

The **review** looked at current rent settings and the principles that should guide an effective public housing rent approach. The review also looked at the effectiveness of public housing rent maxima currently set by HUD and options for change to improve transparency and consistency across the sector.

The main findings were:

- There is a significant difference in rent setting processes between the Community Housing Provider (CHP) sector and Kāinga Ora.
- The removal of the published maxima would assist in levelling the playing field between providers across the sector. There is no policy rationale for the maxima to only apply to the Community Housing Provider sector.

Te Pae Whakahou Hapori – Eastern Porirua Advisory Panel announced

The Minister for Urban Development, Phil Twyford, on behalf of the Eastern Porirua Regeneration Project partners, has appointed a seven-member independent advisory panel, Te Pae, as Kaitiaki (Guardian) of the vision and objectives of the Project.

The Eastern Porirua Regeneration Project is a partnership between the Crown (including the Ministry of Housing and Urban Development), Porirua City Council and Te Runanga o Toa Rangatira (Ngāti Toa) to invest in housing, infrastructure, community facilities, town centres, schooling, training, employment, and social services.
