Budget 2021 Announcement

The Minister of Finance, Hon. Grant Roberston, delivered <u>Budget</u> 2021 on Thursday the 20th May. For those concerned with economic inequality and issues of poverty, the benefits increase of up to \$55 dollars per week is welcome news. Whether the amount is too much or too little has been opined upon by many commentators across the economic and political spectrum.

One way to ensure that increase results in better outcomes for whānau is to ensure that it isn't simply passed along to landlords in

higher rents. The \$380 million investment in Māori housing is great news! The ring-fence put around \$350 million from the Housing Acceleration Fund for a Māori Infrastructure Fund to help unlock whenua Māori potential will ensure a joined up approach between the housing and required infrastructure. Congratulations to the many organisations and people who have fought long and hard for investment at this scale, including our colleagues at Te Matapihi.

No other significant housing investments were made to follow the \$3.8 billion Housing Acceleration Fund announced at the end of March. Details of that funding are still being worked through and the ability to increase affordable, retained rental homes through community housing providers and Māori providers is not yet known. We anticipate engagement soon on the \$350 million in the redirected Residential Development Response Fund.

Providers are also still awaiting policy announcements resolving the disparity in rent levels between registered Community Housing Providers and Kāinga Ora, and on changes to the use of the Operating Supplement to encourage new supply. We are hopeful these will be coming soon and accelerate delivery from registered providers to complement the delivery from Kāinga Ora.

Tauranga Community Housing Trust Builds More Homes For Community's Vulnerable



As the demand for rental properties around the country soars, there is a risk that the most vulnerable members in society are being left behind. Tauranga Community Housing Trust (TCHT) is working to change that by improving access to more quality, sustainable housing in their region.

TCHT has built 12 new one-bedroom homes in Gate Pa which are due for completion at the end the month. The units are designed to be accessible to Lifemark 4 standard and are well designed for ageing in place. They include individual gardens, disability car parks, accessible pathways, and landscaping.
