Child Poverty Monitor 2020 report released

The Child Poverty Monitor is a partnership between the JR *McKenzie Trust, the Office of the Children's Commissioner*, and the New Zealand Child and Youth Epidemiology Service (NZCYES) at the University of Otago.

Each year the Child Poverty Monitor partners choose indicators that reflect aspects of the extent to which children and young people in Aotearoa grow up in households with the resources for everyone to thrive

The latest report was released on December 2 at The Beehive.

Guidelines on the right to a decent home seminar / engagement available online

Community Housing Aotearoa hosted a seminar and engagement session on the Human Rights Commission's draft Guidelines on the right to a decent home on 7 December. HUD New Supply webinar recap

Te Matapihi and Community Housing Aotearoa assisted HUD to organise a webinar covering the new supply process on Tuesday 8 December. More than 60 participants heard the latest news from the HUD Housing Supply Team about the application process, the types of proposals that have been funded, the value for money framework and draft design guidelines to be consulted upon in early 2021. For those unable to attend, here is the presentation. Stay tuned for additional webinars in 2021 once the Public Housing Plan is released and the funding settings are confirmed.

Housing in Aotearoa: 2020

Statistics New Zealand released the <u>Housing in Aotearoa:2020</u> report on 8 December. The report brings together a range of housing information – from official and government administrative statistics – to address some of the key questions identified in <u>Review of housing statistics report 2009</u>.

The analysis in 2020 (based primarily on data from 2018) focuses on how housing intersects with people. How well does New Zealand's housing stock provide suitable, affordable, warm, safe, and secure shelter for its citizens? Where are the gaps and inequalities? Housing can act as a visible manifestation of inequality but can also act as a medium to address it. Also included is a brief discussion on how housing interacts with the environment, and the relationship of housing with climate change.

The Shift Aotearoa conference 2021 | planning and engagement

Community Housing Aotearoa has developed a <u>proposed approach</u> to our biennial conference, planned for June 2021. We want the conference to offer a sharp and clear opportunity to agree and plan for priority changes across the system and the issue we confront. We are planning across 3 key areas, each of which will form a dedicated work programme from January 2021:

- Constitutional transformation: how can conference 2021 build on the dialogue introduced by Dr Moana Jackson and others at the 2019 conference? Many housing matters have constitutional foundations – is it useful to draw a clearer line between constitutional issues and housing system settings and policies?
- Housing system settings: we are planning significant engagement in early 2021 to distil a small set of shared priority settings and policies.

 Narrative change: media coverage of housing is back to incendiary levels – we'd like to see the drama and conflict narrative taken out, replaced with strategic information sharing around real issues and achievable solutions.

Our proposed approach includes three streams of engagement ahead of and beyond the conference – we want to build a clear pathway of work from conference 2021 to conference 2023, which will fall just ahead of the next general election.
