An update on methamphetamine contamination in rental accommodation



Methamphetamine contamination in housing was the topic of the last AHI networking meeting in Wellington where HNZC presented on the work they are doing in this area. Read more about this event here.

Committee set up to develop new standard

Government set up a new committee in May to develop a standard (NZS 8510) to cover the testing and remediation of properties contaminated by the manufacture or use of methamphetamine. The aim of the standard is to develop guidance on methodologies, procedures, and other supporting material for a consistent and effective approach to managing the testing and remediation of affected properties and treatment of their contents.

The committee will hold its first meeting at the end of this month and a draft of the standard will be released for public comment later in the year. The final standard is expected to be published between the end of January and June 2017.

The need for policies and procedures

A recent email to CHRA registered community housing providers highlighted this issue for providers of rental accommodation. CHRA have recommended that all community housing providers consider implementing policies and procedures for the identification and treatment of methamphetamine contamination for properties in your portfolio. Consideration should also be given to the development of

policies and processes for keeping staff and tenants safe in such circumstances.

Emerge Aotearoa has been leading the way in developing policies for the testing and treatment of methamphetamine contamination. To assist you in developing your own policies in this area they have kindly agreed to share these policies with the wider sector. These policies and procedures are now available on the Community Housing Aotearoa website here.

CHA and Emerge Aotearoa are providing these draft policies regarding methamphetamine contamination for the purpose of sharing information among community housing providers. Each organisation will need to determine the right policies for their own organization. As this is an evolving issue with little regulatory certainty at the current time, the policies are provided for use at your own risk and neither CHA nor Emerge Aotearoa warrant their applicability to your particular situation.

Community Housing Regulatory Authority (CHRA) Update

CHRA also have a new website and if you haven't done so already – have at www.chra.mbie.govt.nz. It's designed so the user can get the information you need with three gateways: providers wanting to apply

for registration; providers already registered; and users wanting to access the register to see which providers are registered.

Over the coming months CHRA will be publishing a series of guidance notes on particular topics related to registration and compliance. The first guidance note on the process related to the suspension and revocation of registration has just been published and can be viewed here.


Housing Investment Fund (HIF) letter response

Housing affordability stress affects low income Australians paying a significant proportion of their income on housing costs. The 30:40 indicator defines housing stress as affecting households in the lower 40% of the Australian household income distribution and who are also paying 30% or more of that income on housing costs. A project to improve fire safety for supported housing is on track for completion by the end of the year. It is part of MBIE's Fire Programme. "It's important to have everyone on board as we develop fire safety solutions for those living in supported housing," says Chris Rutledge, Fire Programme lead. "We're pleased to report we are progressing a shared governance agreement between MBIE and the New Zealand Disability Support Network, Housing New Zealand Corporation and Community Housing Aotearoa (CHA) for the proposed design guide and code of practice for supported housing." On 7 July, Lifewise is inviting business and community leaders to experience life on the streets through their annual **Big Sleepout** which raises critical funds to tackle homelessness. This year Lifewise aims to raise \$400,000 through the event to implement the Housing First model to help at-risk Kiwis into homes and support them to live independently.
