2016-17 Budget: Where's the investment in housing?

In our press release on the Government budget announcements that we sent out today CHA has asserted that the budget band aids fail to offer a strategic solution for the social and affordable housing crisis.

We are better than this – we know how to deliver warm, safe, affordable housing for all – but we seem to lack the ability to get strong consensus to action across business, politics, the community housing and social services sectors. Why? **Shamubeel Eaqub in this opinion piece** is asking us to think about the right question – and suggests we're facing a crisis of conscience.

There are many solutions – and community housing providers are delivering them every day. We propose what a real action plan would look like in **Our Place** that would scale up our sector to deliver 15,000 more homes over five years. That would triple our sector's size.

This plan, that we're working on with you, connects many dots: access to land at a 'retained affordable' price; access to \$200M of capital annually; long term IRRS contracts for a stable rental income that ensures true affordability to the household; pathways to home ownership; and the list goes on.

What do we think of Peter Dunne's call for a national housing conference – a get together across the political spectrum? Auckland Deputy Mayor Penny Hulse called for a cross-party agreement on housing last year. Minister Bennett got it half right by saying that New Zealand's housing problems are not new.

This train wreck that we're now in has been building over the past 15 years - successive Governments have failed to act boldly enough to

prevent it. And it is also true that it will take a further 10-15 years before enough solutions kick in to relieve the pain permanently. Which is why we need long-term leadership with deep impact. For Minister Dunne and Deputy Mayor Hulse's idea to work they're going to need to adopt Mr Eaqub's premise – that **we need to restore our conscience and make sure our economy delivers a home for everyone**.

Oh - and when we do get everyone together for that conference – lock the door until there's consensus and a commitment to implement the action plan.

What do we mean by Housing First?

International evidence demonstrates that it costs less to provide appropriate, secure housing and in-home support, than to continue providing the same person with sporadic, ongoing emergency and institutional assistance.

A Housing First approach prioritises moving people quickly into appropriate housing and then immediately providing access to wraparound services to address the other issues in their lives. Last year CHA and Lifewise Trust invited Sam Tsemberis, considered the father of Housing First, to present at the CHA IMPACT 2015 conference in October.

A Housing First community of practice group has recently established and involves community housing groups who are sharing practice and learning about Housing First in New Zealand.

Healthy Homes Guarantee Bill (No 2)

Public submissions are being invited on this bill.

The Healthy Homes Guarantee Bill (No 2) is a members' bill in the name of Andrew Little. The bill proposes to amend the Residential Tenancies Act 1986. Its intention is to ensure that every rental home in New Zealand meets minimum standards of heating and insulation. Under the bill, the Ministry of Business, Innovation and Employment would set standards that landlords are required to meet.

Submissions should be forwarded by 23 June either online using the parliamentary website or to Parliament by mail.

Residential Tenancies Amendment Bill

Meanwhile the Residential Tenancies Amendment Bill passed unanimously through the committee stages of Parliament on 24 May and requires all rental properties to have smoke alarms by 1 July 2016 and be insulated by 1 July 2019. New appointment to the Otautahi Community Housing Trust

The Trust has recently appointed Cate Kearney as its Chief Executive Officer. Ms Kearney has worked and volunteered in the mental health, addictions and community services sectors for 21 years, including 16 years in leadership positions. Her most recent position was Service Manager for the Canterbury District Health Board's Specialist Mental Health Service. She will take up her new position with the Trust on 13 June 2016.

The Otautahi Community Housing Trust will take over management of Christchurch City Council's social housing service in the second half of this year. The Council remains the owner of its social housing units and proposes to lease them to the Otautahi Community Housing Trust to manage at which time the Trust would become the new landlord for individual tenants.
