### Auckland Unitary Plan – why it needs to mandate affordable housing

The recommendations from the Independent Hearings Panel on the Auckland Unitary Plan were released on 27 July, 2016. They have revealed a plan for more widespread, higher-density housing than previously proposed – which we strongly support. Legislation requires the council to settle the plan by 19 August, or seek a one-month time extension.

The housing affordability requirements have not been included in the panel's recommendations.

There is still time for Auckland Council to put them back in! Read Peter Jeffries' speech at the launch of the More Homes Coalition on 1 August and CHA's letter to Mayor Len Brown and Auckland Council here.

#### Supporting better housing outcomes



Community Housing Aotearoa applauds Government's move to invest \$9 million over the next two years into two internationally recognised models aimed at curbing homelessness.

It's an example of what we have all been asking for. Now let's make sure the procurement works well too. Chief Executive Scott Figenshow says the investment is a positive step forward to support the country's most vulnerable people. The funding will be partly used for a Housing First model which moves people into independent, permanent housing and provides additional support and services to address the issues underpinning homelessness. In addition, the Better Housing Outcomes funding will help providers prevent homelessness.

"What this does is put both services and houses at the heart of the healthy strong communities – if you fix housing you can fix a host of other social issues. New Zealand's social housing sector received a great insight into the Housing First model when it hosted Americanbased Dr Sam Tsemberis at the CHA conference last year, he says. Over the past nine months, community housing and emergency housing providers have formed a community of practice to develop best practice for implementing Housing First in New Zealand. It's great to see Government recognize the innovation and experience in New Zealand.

# Update on standard for testing and remediation of methamphetamine contaminated properties



The committee that will develop the new standard for testing and remediation of methamphetamine-contaminated properties (NZS 8510) held its second meeting on 25 July 2016 in Wellington. ### Drawing the line – how many state houses do we need?

Alan Johnson, Social Policy Director at The Salvation Army presented at the last Australasian Housing Institute event in Auckland on 21st July.

The presentation provided a critique of the current Government's stance that the overall numbers of state housing should reduce to 60,000 by 2017. Alan argued that the provision of state housing should be based on the type and extent of need and a clear understanding of the interventions required to address this need. He believes the underlying motive for Government to reduce dependence on housing, by moving people along the continuum, ignores the housing reality for many.

Alan pointed out overseas studies of future demand for social housing combined with decreasing levels of home ownership and an aging population as indicators that the need for social housing, in New Zealand's case primarily provided by the state, will require a much larger investment – not a decreasing one.

He commented that the best response to the housing crisis we currently face is "a well-supported state and NGO social housing system, based on the idea and ideal that we have a collective responsibility to support vulnerable people and families in and through housing in the hope that they can make the best of their lives as our fellow citizens." Jenny Samms has been the CEO of AHV since 2013. She has had a career spanning 35 years in Federal and State Governments in areas such as education and training, labour market reform and employment programs, Aboriginal Affairs and social policy.

#### Tim Chatfield, Chairman - Aboriginal Housing Victoria

Tim Chatfield has been associated with Aboriginal Housing Victoria since its very early years and the Chair since 2006. He is also the CEO of Budja Budja Aboriginal Cooperative, a member of the Aboriginal Cultural Heritage Council Victoria and a former ATSIC Commissioner. He successfully advocates for the rights of Aboriginal people and has a long history in service delivery, economic development and cultural heritage.

### Robert Byers, President & Chief Executive Officer - Namerind Housing Corporation

Robert Byers is a proud Canadian from the Little Black Bear Cree Nation. He is President and Chief Executive Officer of Namerind Housing Corporation, a not-for-profit Aboriginal housing provider in Regina, Saskatchewan, Canada. Prior to his work with Namerind, Robert had a long career in residential and commercial construction and procurement. He is a member of the City of Regina Mayor's Housing Commission, serves on the Regina Community Advisory Board for the Homelessness Partnering Strategy and is Board Member of the Canadian Housing Renewal Association where he chairs their Aboriginal Caucus.

#### Robert J Hall, Aukai Pacific, LLC

Robert Hall has over 35 years of experience in Hawaii's Housing Industry. Before retiring from State government in 2011, he last served as the Deputy Director of the Department of Hawaiian Homes Lands, where he worked for over 15 years and is considered an expert on native Hawaiian housing programs, policy development, and overall management. During his tenure he guided the federally funded Native American Housing and Self Determination Act (NAHASDA) program and implementation of the Native Hawaiian Housing Block Grant (NHHBG), had oversight of the Homestead Services Division, which managed admissions and occupancy and was instrumental in creating the department's Home Ownership Assistance Program, which prepared native Hawaiians for homeownership. From 1983 to 2003, he served in executive capacities with the Housing and Community Development Corporation and Hawaii Housing Authority.

#### In the news



The latest monthly QV House Price Index (2 August) shows that nationwide residential property values for July have increased 14.1% over the past year. Values rose by 6.1% over the past three months and are now 45.4% above the previous market peak of late 2007.

When adjusted for inflation the nationwide annual increase drops slightly to 13.7% and values are now 23.5% above the 2007 peak. The average value nationwide has now ticked over the \$600,000s and is \$602,434. The Auckland market has increased 16.0% year on year and 5.2% over the past three months. Values there are now 81.6% higher than the previous peak of 2007. When adjusted for inflation values rose 15.5% over the past year and are 54.2% above the 2007 peak.

#### An update on the Māori Housing Network



It's been a busy year for Te Puni Kōkiri's Māori Housing Network. With funding going to 87 projects a range of initiatives have been funded that include: emergency housing, infrastructure development, feasibility planning, housing repairs, papakāinga building, capacity building, housing facilitation and papakāinga workshops and new builds.

The regional breakdown of projects into: Ikaroa-Rāwhiti, Tāmaki Makaurau, Te Tai Hauāuru, Te Tai Tokerau, Te Waipounamu and Waikato-Waiariki can be found <u>here</u>.

The network was been set up to support the energy, enthusiasm and entrepreneurship in the Māori housing sector with information, advice and practical support to build capability. Its funding focus is on smaller scale projects that: • improve the quality of housing • build capability and capacity in the sector, and • increase the supply of affordable housing.

### Extention of delivery of time frame for 1000 social housing places in Auckland

An addendum has been issued for GETS RFx Id: 17027338, MSD 2015.067 - IRRS Housing Services Auckland (Closing on 25/11/2016 12:00PM).

Please note the targeted time frame to provide an additional 1000 social housing places in priority Auckland suburbs where vacant possession is available by June 2018, has been extended by 18 months, from June 2018 to the new date of December 2019.

CHA has contacted MSD and Ministers offices suggesting that the real fix is to also extend the application date beyond November 2016. If we want to build a genuine pipeline of social and affordable housing there should be no closing date, and an open process for at least 5000 additional IRRS places - open until filled.
