ON OUR DOORSTEP A Voice For Homeless Youth

Focus on youth homelessness

On our doorstep is a documentary made by students from AUT's master of human rights class that aims to shine a light on lives within a largely hidden demographic. During the production process, student Monique van Veen said she heard a "massive spectrum of reasons" why youth ended up homeless; from fleeing violent families to feeling marginalised in smaller towns and drifting to Auckland "to find their people". Van Veen said the definition covered a broad spectrum of living arrangements - "everything from literally sleeping on the streets to living in a really unfit, unhealthy home". Methamphetamine contamination draft guidelines issued

Standards New Zealand is currently consulting on updated standards for the Testing and Decontamination of Methamphetamine Contaminated Properties (NZS 8510).

The new standards will have major implications for the way social landlords deal with the testing of properties for methamphetamine, both manufacture and use. It will also affect the remediation techniques used and has implications for both policies and procedures for the testing of properties and for remediation. They will have an impact on organisations asset management and will need to be built into maintenance budgets and organisational risk strategies.

For the first time the draft standards recommend different thresholds for testing properties where Methamphetamine has been used as opposed to manufactured. While this approach is welcomed, the levels of contamination proposed are still very low, potentially resulting in high costs to landlords irrespective of the cause of contamination. The guidance on approaches to testing and decontamination do not make clear enough recommendations on the most appropriate form of remediation for properties where Meth has been used rather than manufactured. They also take a very conservative level of contamination not supported by robust scientific foundations as discussed in the NZ Drug Foundations 'Matters of Substance' article of August 2016.

HNZ housing stock transfer in Christchurch

Te Wai Pounamu community housing network hosted Karen Mitchell, Treasury, and Scott Gallacher, Ministry of Social Development, on 2 February to discuss the IRRS Social Housing Purchasing Strategy and the market sounding process for the transfer of Housing New Zealand properties in Christchurch.



- Annual rent rises hit low-spending households
 Beneficiaries and low-spending households experienced the
 highest inflation over the past year, Statistics NZ reported.

 From the December 2015 quarter to the December 2016
 quarter their overall costs increased 1.4 percent. This was
 more than double the rate of inflation experienced by New
 Zealand's highest spenders (up 0.6 percent). Go here.
- New Zealand short 60,000 homes. New Zealand is up to 60,000 houses short, with Auckland needing as many as 35,000 homes, according to estimates in a Treasury document. The figures are part of a housing supply and demand forecast produced in September of 2016 and released in January as part of an Official Information Act request. <u>Read more here.</u>

Smokefree Social Housing Toolkit: a guide for the design and implementation of smokefree policies in social housing



Community and Public Health has developed a toolkit to assist social housing providers to implement smokefree policies in social housing settings. Increasingly, improving population health has become a shared goal across many sectors, including social housing, and a smokefree social housing policy can result in win-wins for tenants, housing providers, and the wider community.

The Toolkit draws on international research as well as on their experience working with the Christchurch City Council to implement their smokefree social housing initiative. The Toolkit is 'clickable' online as well as providing a number of downloadable templates, checklists, survey tools, a staff training PowerPoint presentation and links to other resources. Research

- Cold homes harm NZ youth health and schooling. A new study from the University of Otago, Wellington has found that young people are experiencing increased health problems, stress, and adverse social effects from cold housing. The article in the journal Social Science and Medicine Population Health by Dr. Kimberley O'Sullivan at He Kainga Oranga/Housing and Health Research Programme was co-authored by researchers from the University of Otago and more unusually, young researchers from Waiopehu College in Levin, Horowhenua. <u>Read more here.</u>
- State of the Nation report February 2017. The Salvation Army's 10th annual 'state of the nation' report says youth offending and teen pregnancy have more than halved, jobs and real wages are rising, alcohol consumption and drinkdriving are falling, and welfare rolls are the lowest since 2007. But it says homelessness "unseen in more than a generation", persistent child poverty and a record imprisonment rate point to the country "heading off the track". <u>Read the report here.</u>
