Message from CHA's Chief Executive

Kia ora koutou,

It has been good to see more of you over the last week, albeit in circumstances that I know are at best uneven for many of you.

We have heard strongly that we need to ensure priority vaccines for our people, more vaccine mobility for the rough sleepers and homeless communities in our care, and to ensure we have good local and national safety nets available for mental health.

We've heard that planning for supplies and food is difficult with the day by day approach.

We've also heard that our rangatahi/youth have specific safety needs that require addressing.

There is work underway on each of these things – please keep your feedback and requests in relation to these and whatever else you may need coming. Chris Glaudel and I have another opportunity to

meet the Minister next Friday 3 September and feedback on issues is most welcome.

In the middle of all of this we have a submission to the Productivity Commission's 'a fair chance for all' inquiry due, which our team has put together and is attached to this newsletter for you to take a look at. It's a reminder that while we respond to the Delta crisis, we still need to work on the long-term changes that we need to address our housing crisis. That's what we're here for at CHA and I hope you can endorse our submission (and have one less thing on your plate).

Productivity Commission Submission - Include Housing in the Terms of Reference

Sharing ideas and issues

Update on Te Matapihi Zoom Meeting

- Some of the CHA team attended the Te Matapihi 'zui' on Tuesday to hear from iwi and Māori providers about how they're doing. It was important to hear some of the common themes coming through with respect to access to mental health services and the mobility of vaccinations — both topics Te Matapihi and CHA have been able to raise to the Ministers as a joint group.

Update on CEO & Sector Leaders Forum

- The CEO & Sector Leaders Forum was focused on the COVID response, the redirects issue and investigating how the change to the

Operating Supplement will work in practice for different providers. The Forum also heard from the Productivity Commission's Geoff Simmons about the importance of having the housing voice heard in the 'fair chance for all' inquiry that is getting underway.

Update on Te Waipounamu Network

- Our providers in Te Waipounamu met online to discuss some of the key COVID issues they're facing and to get an update on recent engagements with the Minister. They also heard from Geoff about the Productivity Commission's work.

Government support for your organisation

Ministry of Housing and Urban Development - Te Tüāpapa Kura Kāinga

Ko te reo mihi tēnei te maioha ake nei ki a koe, kei te mōtoi kahotea, me te tangi ki $\bar{\text{o}}$ tāua mate

huhua o te wā, ki te iwi kua whetūrangitia, tauārai i te pō, titoko o te ao mārama, tēnā tāua.

We wrote to you last week following the Prime Minister's announcement that Aotearoa New Zealand was moving to Alert Level 4 Lockdown. Now that the lockdown has been extended, we want to let you know Te Tūāpapa Kura Kāinga continues to support your organisation and your mahi to ensure you can provide emergency and temporary accommodation to those in need.

We want to acknowledge the fantastic job all our housing providers have done to ensure the homeless have a roof over their heads during lockdown. Thank you for working so hard to support individuals and whānau experiencing homelessness to move

quickly into stable accommodation and access wider social support to address their needs.

We are working closely with the Ministry for Social Development to ensure everyone has accommodation. People with nowhere to stay should contact MSD who will support them with emergency housing. Government Ministers and officials are meeting regularly with lwi to ensure effective engagement to ensure strong open communication continues in our response to COVID 19. These meetings enable open dialogue and actions for agencies to follow up on.

The collective work done across agencies in response to COVID-19 in 2020 means we're in a much stronger position to respond swiftly now to ensure our providers and staff can operate under any alert level. We continue to work with all our providers as they assess the level of need and have responded quickly to these changing circumstances.

A number of additional units have already been secured in Auckland in response to a request from one of our providers and additional places have been sourced in Whangārei for rough sleepers. A big thanks to our providers like Kahungunu Whānau Services who have also begun offering vaccination programmes for the homeless in and around Wellington amongst the wide service provision they provide to whānau in need, while organisations such as Wellington City Mission have been delivering shopping orders to support individuals and families where needed.

HUD is working with the Ministry of Health to provide further information about vaccination needs. DHBs in some areas have already begun working with providers on the initial vaccinations. We continue to support our partners and sector leads Te Matapihi and Community Housing Aotearoa who have contacted other housing providers including iwi and Māori organisations to access immediate needs required for the homeless.

Our providers have told us that while there has been no significant change to the demand for emergency and temporary accommodation, there have been pockets of increased need and we've been able to respond as required to add capacity. Evictions from emergency and transitional housing need to be a last resort, now more than ever.

However, welfare of other residents and staff is also important. Talk to your relationship manager if you need any support with security.
