When it comes to mental health, that obviously has a big impact, and it was encouraging to hear the Prime Minister name it and suggest places to get support over the weekend. And we know there are operational impacts in terms of making the decisions about what is urgent and critical and what can be left for "after the outbreak".

Given the potential severity of Delta, we're updating our guidance, which Clare Aspinall talked through at the sector call and we have available on our website. We hope this will help you with prioritising.

In one of our recent newsletters we talked about The Workshop who are a research, consulting and training organisation that focuses on communicating and building public support for policies and practices. They have developed a guide around How to talk about COVID-19 vaccinations: Building trust to help talk effectively about Covid-19 Vaccinations to people who may be hesitant about getting vaccinated.

In terms of what is in and out of your control, if you ever need a sense check, or you're getting requests that are asking you to take on responsibilities outside of your lane (or simply your contracted commitment), please let us know as we can help work through some of those pressures directly with Ministry of Health, HUD and others. Whatever you need – CHA is ready to respond.

In the meantime, I look forward to my scheduled Zooms with many of you and to the moment when I can meet you all in person.

An update on the family violence and physical assault regulations

While most of the changes under the Residential Tenancies Amendment Act 2020 came into effect on 11 February 2021, there were two remaining changes that were due to come into effect in August 2021. These changes relate to family violence and physical assault.

These two changes rely on regulations that are currently being developed by the Ministry of Housing and Urban Development. The provisions in the Residential Tenancies Act 1986 will not be able to be used until the regulations take effect. It's important that the Government takes time to consult with relevant organisations and make sure the regulations are appropriate.
