There's no shortage of cash piled up in New Zealand's banks and pension funds yet we have a shortage of affordable housing. So how do we connect all the money in the institutional funding sector with the housing projects that would begin to solve the housing crisis?

# **Government Policy Statement on Housing and Urban Development [GPS-HUD]**

The GPS-HUD and MAIHI Ka Ora, the National Māori Housing Strategy were released at the end of last month. Important updates from the consultation material include increased specific references to the community housing sector and an explicit statement regarding the human right to adequate housing. We will continue to provide coverage and opportunities to engage as matters arise.

The Minister is required to put in place the GPS-HUD under the Kainga Ora Homes and Communities Act 2019. The key provisions are anchored in section 23 "Purpose and content of GPS" [text abridged]:

- (1) The purpose of the GPS is to-
- (a) state the Government's overall direction and priorities...; and
- (b) inform and guide the decisions and actions of agencies involved in, and the activities necessary or desirable for, housing and urban development.
- (2) The GPS must include the following:
- (a) the Government's overall direction for housing and urban development, which must include a multi-decade outlook:
- (c) how the Government expects Kāinga Ora–Homes and Communities to manage its functions and operations to meet the Government's direction and priorities.

This re-established Government's role as the direction setter for the housing system; it speaks directly to an expectation that the agencies involved follow that direction; and it specifies the GPS as a tool to set out the Government's expectations of Kāinga Ora. Importantly this section also requires the GPS to take a multi-decade outlook.

CHA and the CEO and Sector Leaders' Forum is currently working on detailed feedback to the GPS and we look forward to seeing timelines for implementation. If you have any burning issues you'd like to contribute, let us know.

This one hour webinar features representatives from Melbourne City Mission, AHURI and Victoria's peak homelessness body – the Council to Homeless Persons. It will include initial findings from research that AHURI's Professional Services team is conducting in partnership with Melbourne City Mission (MCM).

There are many worthwhile programs and initiatives directed towards tackling youth homelessness in Victoria, and significant state funding is committed to supporting the sector in these efforts. However, the issue has not received strategic policy attention for well over a decade and currently there is no overarching plan or strategy. The Victorian Government is developing its 10-Year Housing Strategy and a substantial review of homelessness policy in the state. Join the discussion on how youth homelessness fits into this emerging policy landscape.
