New COVID-19 Housing Support Resources Available

Te Tūāpapa Kura Kāinga – the Ministry of Housing and Urban Development (HUD) has developed two new resources for housing providers (including moteliers). These offer important advice on preparation and what to do if there is a positive case at the property you manage or work at and are available below:

Applications Open for New Initiatives Aimed at Helping Reduce and Prevent Homelessness

Local Innovation and Partnership Fund

Applications are now open for round two with up to \$6 million available to support local initiatives that prevent homelessness. Māori providers, hapū, iwi, community groups, non-government organisations and local councils are invited to submit their applications. Find out more and download the application form [here](#). Applications close on Monday, 28 February 2022.

Transitional Housing for Rangatahi Youth

The updated Invitation to Partner (ITP) was released on GETS early November. The ITP now includes a section on Rangatahi Youth focussed Transitional Housing for providers who may be interested in delivering dedicated Rangatahi-Youth services or initiatives.

New providers are welcome to apply [here](#). Existing approved transitional housing providers are not required to complete a new ITP application and should contact their HUD relationship manager if they are interested in delivering dedicated TH services for Rangatahi-Youth. The Rangatahi TH service will be delivered to young people aged 16-25 and will be modelled on the Transitional Housing service.

Single Site Supported Housing

HUD has released a Request For Information (RFI) for Single Site Supported Housing (SSSH). SSSH is where tenancies are located within one building or on a contiguous area of land, with support services provided on-site.

HUD is looking to engage early with the sector about their thinking on the framework. They are seeking feedback from all interested parties on the SSSH concept. Along with information gathered through other sector engagement activities, they are seeking information through the RFI, to inform how on-site support services could be delivered in a range of settings and contexts and with varied cohorts in various locations. They are also seeking to gauge the level of interest in delivering the types of services that could be covered by a SSSH framework.

Sustaining Tenancies

A targeted Registration of Interest (ROI) for additional iwi partners and Māori providers for the Sustaining Tenancies (ST) Providers' Panel is now open. The aim is to improve service outcomes for whānau Māori tenants by increasing the number of ST places delivered by iwi partners and Māori providers. While the ROI is open

to iwi partners and Māori providers in all regions', limited funding is available and priority will be given to the areas listed below that have been identified as having little or no kaupapa Māori ST service delivery:

- Waikato region (Hamilton)
- Bay of Plenty region (Rotorua)
- Bay of Plenty (Tauranga)
- Bay of Plenty (Tāupō-Tūrangi)
- Taranaki region (Whanganui)
- Taranaki region (rest of Taranaki)
- East Coast region (Hawke's Bay)

There are a total of 200 additional ST places available. Incumbent Panel members who are also iwi partners or Māori providers can contact their HUD Relationship Manager to discuss additional service provision.
